RESOLUTION NAMING ROBERT GOUDIE RECIPIENT OF THE WEST MARKET OUTSTANDING NEIGHBOR AWARD

WHEREAS, Robert Goudie, an original owner in the West Market Community Association, has been a model of exemplary service and dedication to the community; and

WHEREAS, that service began as the President of the Association's Board of Directors, the most important and time-consuming position in the Association and one that Robert has held for the past seven years; and

WHEREAS, Robert's accomplishments as President of the Board of Directors are too numerous to recount in total, but they include completing the revisions to the community covenants, a comprehensive overhaul of the annual budget structure, the establishment of the Community Improvement Reserve to facilitate a structure for providing enhancements to the community infrastructure, overseeing the snow removal process during the record snowfalls in 2009 and 2010, leading the renovation of the community clubhouse and leaving the community in a very solid financial position in these difficult economic times; and

WHEREAS, in addition to many organizational accomplishments, Robert's most visible legacy is the renovation of the West Market community clubhouse; the Board has received many compliments from residents and visitors about the appearance and functionality of the clubhouse since it reopened; and

WHEREAS, one of Robert's greatest legacies to the Board was his leadership on improving the financial stability of the Association and the security of the Community Improvement Reserves; and

WHEREAS, Robert's volunteerism for the community began but has not ended with serving on the West Market Board of Directors, as he also volunteered and was elected to fill an open Reston Town Center Association board position, and he has served and continues to serve with distinction on that board as a resident representative; additionally Robert was a key force in the creation of WATCH, the Working Alliance of Town Center Homeowners; and

WHEREAS, throughout his service to the community Robert has always conducted himself with integrity, focus and class – indeed in talking about Robert with neighbors, the words most often associated with him are integrity and transparency; and

WHEREAS, Robert Goudie has been a model of excellence, setting a wonderful example of what it means to be an outstanding neighbor;

NOW, THEREFORE, in recognition and deep appreciation of Robert's outstanding service to his neighbors, and the active role he played in making West Market such a wonderful community, it is:

RESOLVED, that Robert Goudie is hereby named recipient of the West Market "Outstanding Neighbor Award"; and

FURTHER RESOLVED, that a laminated original of this resolution shall be presented to Robert, and his name shall be inscribed on the permanent Outstanding Neighbor Award hanging in the West Market Club House for all in West Market to enjoy and appreciate as an enduring statement of our gratitude.
